

LIABILITY WAIVER, RELEASE AND INDEMNITY AGREEMENT

Women Can Fly Day

Co-sponsors: Virginia Department of Aviation; The Ninety-Nines, Inc. and its local chapters; Shannon Airport, Suffolk Executive Airport, and Warrenton-Fauquier Airport; hereinafter referred to collectively as the “SPONSORS.”

A flying event co-sponsored by the Sponsors will take place on _____ (enter event date). You have requested that the said Sponsors allow you to participate in the flying event. You acknowledge that participating in the flying event involves inherent risks, dangers, and hazards, which could result in injury or death.

In consideration of being allowed to participate in any way in the program, related events and activities, I, the undersigned, freely accept and fully assume all such risks, dangers and hazards, whether identified herein or not, and the possibility of personal injury, death, property damage or any type of loss resulting from such risks, dangers and hazards. In consideration of said Sponsors allowing me to participate in the flying event, I acknowledge and agree that:

1. The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death.
2. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the Sponsors, their officers, directors, officials, representatives, members, volunteers, and agents used to conduct the event (hereinafter referred to collectively as the “Releasees”), and assume full responsibility for my participation.
3. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, indemnify, and hold harmless, the Releasees from any and all claims, demands, losses, and liability arising out of or related to any injury, disability or death I may suffer, or loss or damage to person or property, whether arising from the negligence of the Releasees or otherwise, to the fullest extent permitted by law.

Photo and Image Release: The participant hereby gives the Releasees the absolute and irrevocable right and permission to use photographs, pictures, and/or images of the participant taken at or derived from his or her participation in the *Women Can Fly* event in whole or in part, with or without alteration or modification, in any and/or all manner and in any and/or all media, in connection with the Sponsor’s activities, programs, publications, and publicity.

I HAVE READ THIS LIABILITY WAIVER, RELEASE AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT INDUCEMENT.
